## **Return to Learn and Continuity of Services Plan 2023-2024**

Utica Community Schools will continue to provide in-person learning for all students and a virtual option for students in grades 3-12, for interested families, during the 2023-2024 school year. All students will continue to be assigned a computer for use in school and at home.

This Return to Learn and Continuity of Services Plan has been prepared to meet the requirements under the American Rescue Plan Act of 2021 and the use of Elementary and Secondary School Emergency Relief (ESSER) III funds. The plan is intended to provide high quality learning experiences for all students and carry out district operations in support of the whole child. The design of the plan enables the district to remain agile and continue student learning while responding to changes in community health trends. Periodically, but not more than every six months during the life of the grant, the plan will be reviewed, and updates will be completed, if deemed necessary.

The plan includes a description of the ways Utica Community Schools will maintain the health and safety of students related to the Centers for Disease Control and Prevention's updated respiratory virus prevention strategies including handwashing and respiratory etiquette, cleaning and maintaining healthy facilities, and health and safety protocols determined in collaboration with the Macomb County Health Department. Based on the CDC's Respiratory Virus Guidance and in consultation with the Macomb County Health Department, Utica Community Schools will determine the appropriate mitigation strategies to continue student learning while supporting the health and safety of students, their families, and staff.

| <b>Health Screening &amp; Student Illness</b>   |  |   |
| <p>Parents/guardians are encouraged to conduct a daily wellness check prior to sending students to school. Students should not be sent to school when they are ill. A child should not return to school after an illness until a period of at least 24 hours where their symptoms are getting better overall and they have been fever-free without the use of fever-reducing medication. Parents/guardians should follow medical professional and/or health department guidance regarding exclusion periods for communicable diseases.</p> <p>All individuals are asked to stay home and away from others (including people in the same household who are not sick) when experiencing respiratory virus symptoms that are not better explained by another cause. Symptoms may include but are not limited to chest discomfort, chills, cough, decrease in appetite, diarrhea, fatigue (tiredness), fever or feeling feverish, headache, muscle or body aches, new loss of taste or smell, runny or stuffy nose, sneezing, sore throat, vomiting, weakness, wheezing. All individuals are encouraged to follow the return to school guidance listed above.</p> |  |   |
